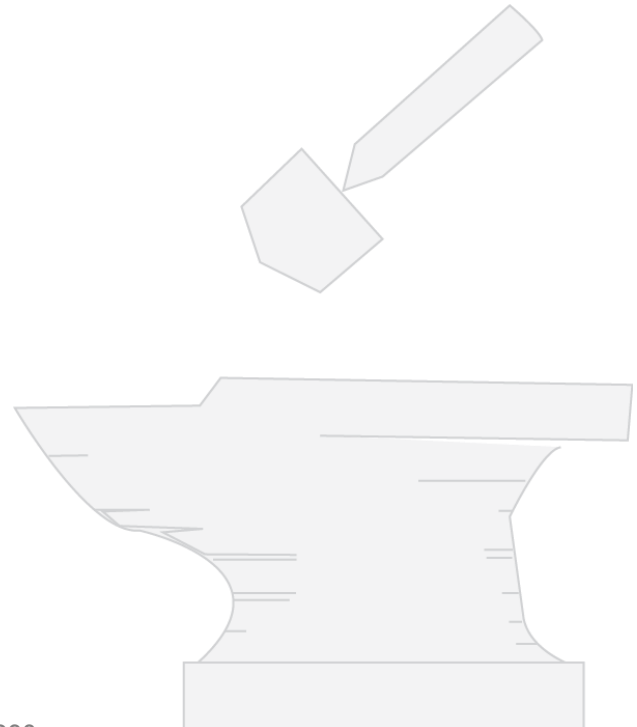

## ADMISSIONS PROCEDURE

Dear Applicant, this brochure is intended to guide you through the admissions process for **Everest International Program**. This process consists of three stages:

### Stage 1: Application Forms and Documents

An application to **Everest International Program** is based on the receipt of all the following documentation:

- 1) Student Information Form
- 2) Contact Information
- 3) Parent's Report
- 4) Recommendation form
- 5) Application Form\*
- 6) Grade Reports (Current Year and Previous Year)
- 7) Physician's Report signed by a doctor
- 8) Family photo
- 9) Psychological Report\* <sup>(1)</sup>

(1) A psychological report is required for each applicant. Oak International will provide the contact for the psychologist who will apply the test and release this report to the Academy. This information is confidential and will be viewed by authorized staff only.

### Stage 2: Supporting Documentation

- Parent's Agreement
- Parental Consent and Medical Authorization
- 7 Passport Size Photos
- 1 Applicant's Passport photocopy
- 1 Birth Certificate
- Written Assessment

Applicants will be given **20 working days** to send the supporting documentation to **Everest International Program** directly. The address to send the package will be given at Stage 3 at the Online Application. However, be aware that **Everest International Program** will not review any incomplete applications. If the school secretary does not receive the supporting documentation within the indicated time, the application will be considered null and void.

*\*Does not apply for Summer Courses*

### Stage 3: Acceptance

The admissions committee will review an application once all the application documents are received. Admissions decisions will be communicated to all applicants via email. There are no guaranteed or reserved places. Placement is subject to availability in each grade level. If a grade level is full, an applicant will have the option of being placed on a waiting list.

Once the applicant has been accepted, the \$3,000 registration fee is due within 20 days. The registration fee is a nonrefundable deposit which reserves the student's place. The registration fee must be preceded by the acceptance letter in order to reserve the student's place.

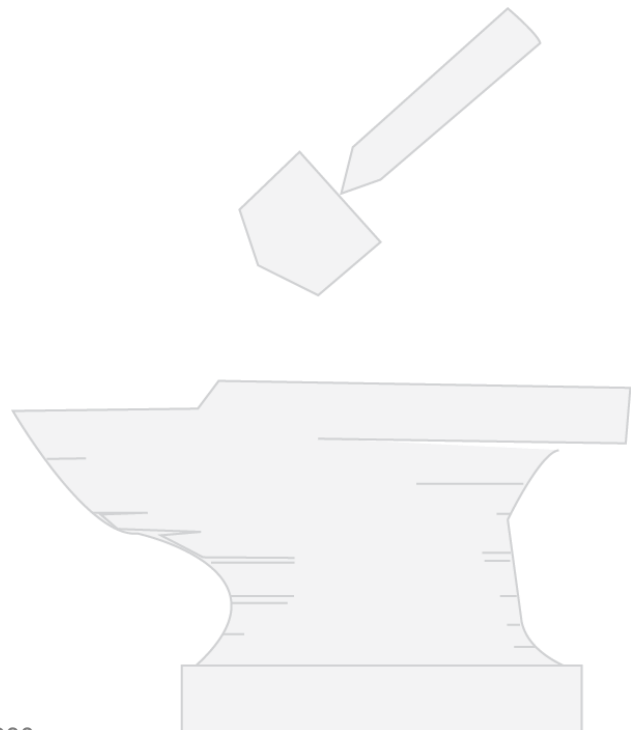
